Please Read & Initial our SUP Board & Safety Rules

- I can swim proficiently and/or use a lifejacket at all times
- I understand I will be entering the Monterey Bay National Marine Sanctuary. I will help preserve the marine eco-system that I am paddling in and will not take specimens, nor fish in restricted Marine Protected Areas. I will not land on the beach between the MB Aquarium and Hopkins Marine Station.
- I understand there is a Federal Law protecting marine mammals and that I could be fined if reported for harassment. I will not disturb, follow, get too close, feed or touch any marine mammal or bird.
- I will stay within 50 yards of adult chaperone and not wander off without permission.
- I will yield right of way to motor boats and sail boats, especially at the mouth of the harbor.
- I am aware of the surf and weather forecast for the day and understand that it can ALWAYS CHANGE, especially offshore winds that may increase and make it difficult to paddle to shore. I agree to pay a rescue fee of \$25 if someone must come to pick me up.
- I have no medical condition that would impair my safety. I understand that I will be exposed to cold water (55 degrees on average) and physical exertion that may exacerbate any condition that I have. I understand a wetsuit is always available at no charge.

ASSUMPTION OF RISK & RELEASE OF LIABILITY

1. I personally assume all risks in the use of equipment. I agree to pay for any damages due to my negligence.
2. I acknowledge that SUP Boarding entails known and unanticipated risks which could result in physical and emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, but are not limited to: open water, cold water, wind, waves, currents, unpredictable weather and environmental conditions, obstacles onshore or in the water (natural or man-made), wildlife (animals, birds fish), and plants, negligence caused by third parties, and my own negligence. Furthermore, TCHS staff and volunteers seek to provide a safe environment and experience, but are not infallible. They might misjudge the weather or terrain, or give inadequate warnings. They might be ignorant of a person's fitness, past experiences or abilities. As a parent, I understand that this participation is completely voluntary. I need to consider my student's prudent judgment and abilities.
3. I expressly agree and accept and assume all the risks existing in this activity. My participation is purely voluntary, and I elect to participate in spite of the risks.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Trinity Christian High School from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of equipment, including any such Claims which allege negligent acts or omissions of Trinity Christian High School.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions that could interfere with my safety in this activity, or else I am willing to assume and bear the cost of all risks that may be created, directly or indirectly, by such condition.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Trinity Christian High School on the basis of any claim from which I have released them herein. It is the intention of the undersigned to exempt and relieve TCHS and associated parties from liability for personal injury, property damage, or wrongful death.

I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and a contract between myself and TCHS and affiliated parties and I sign it of my own free will.
